Click on the [Property Tax Search](#) link on the left menu bar to get started. The database is updated nightly. Online payments are posted the next business day.

The **2021 Dump Permits Stickers** for residential solid waste disposal will be valid from October 1, 2021 to December 31, 2022. If you choose to purchase your permit during the same time you are paying your property tax bill, you will not need any further identification of being a county resident and/or landowner. Your tax bill information will be your identification. A subsequent purchase will follow a separate procedure. Visit the county's website [www.co.burleson.tx.us](http://www.co.burleson.tx.us) for Burleson County's rules & regulations and a list of citizen collection station sites where the dump permit stickers are accepted.

TO PAY BY MAIL OR IN PERSON, please complete the remittance form below and include this form with your tax statement stub and payment.

TO PAY ONLINE, go to [www.certifiedpayments.net](http://www.certifiedpayments.net) and enter Bureau Code 4323644 – Burleson County, TX Property Tax WEB. To ensure proper credit please pay for dump sticker permits separate from your tax bill. Enter the payment amount (\$30 per permit), and under Reference # please enter your Owner ID number or Parcel ID number found on your tax statement. Your payment type *Dump Permit* can be selected from the dropdown menu at the bottom of first page. When entering your tax payment, please select the Type of taxes you are paying and the corresponding Owner, Parcel, or Account numbers as the reference. **PLEASE NOTE:** We will be unable to honor an internet payment request for a dump permit unless the Reference # field contains the Owner ID or Parcel ID that matches the same name as the cardholder authorizing the transaction.
